**Note for existing graduates of the Diploma or Certificate options who wish to take additional credits toward the Degree:** This chart is based on our *current program profiles* (effective September 2010). Students who graduated under earlier profiles may not have all the courses as indicated above. For example, a Diploma graduate who started in 2008 and graduated in 2010 will not have taken Legal Analysis (LAW 110) or Criminal Law (LAW 130). Graduates from more than 15 years ago may not have other credits such as Insurance Law I (LAW 400) or Intellectual Property (LAW 450). However, our faculty and university degree advisors are committed to recognizing our graduates' education and work experience. You may have already acquired substitution or transfer credits so that taking these missing degree courses is not necessary. For instance, Legal Communications (CMNS 116) or Writing for Paralegals (CMNS 179), courses under the old Diploma profile, could be substituted for Legal Analysis (LAW 110). It is also possible to acquire credits through the [Prior Learning Assessment](#) (PLA) process. Finally, please note that LAW, IPS and LGAS courses that are equivalent will only be counted once. For example, if you have taken IPS 252 and then later take LAW 200 they will only count as one 3-credit course.
